Course Description

This course focuses primarily on the political dimensions of our historical and contemporary relationships to the natural or non-human world. While some attention will be paid to ethical fundamentals (such as the notion of an environmental ethic) and to what could be understood as classically 'philosophical' issues (such as the metaphysics and epistemology of our theories of the natural world,) we look at these with an eye to discovering their just application or implementation in existing circumstances. Students should expect the course to be rather more pragmatically oriented than might be usual in philosophy courses generally. Students should also expect, as a consequence, to deepen their understanding of the political issues and problems engendered by our attempts to achieve environmental justice and efficiency, and to articulate, frame, and formulate reasoned arguments, both orally and in writing, concerning these matters.

Required texts

Scheduled readings to be assigned on a weekly basis, dependent on class progression through the required material (my expectation is that we will cover the entirety of the Dryzek & Schlosberg volume, with the exception of Part 2, section iii, as well as some additional material)

Please note that the following policies govern student conduct in this course:

Failure to abide by this policy will result in a grade of 0 for the relevant assignment.
- 5. plagiarism is a serious academic offense and will be dealt with accordingly, as will any case of academic misconduct. Students are encouraged to acquaint themselves with article I, section 1, of the Code in order to prevent any inadvertent violations.
